

#### **AUGUST 22: CHICAGO, ILLINOIS**

Built by the American Shipbuilding Company in 1917, this former ship is now home to the world's largest Great Lakes maritime museum. Explore the cargo's rich collection of photography, shipwreck artifacts, and fascinating nautical exhibits. Then visit the mighty Soo Locks—one of the world's largest and busiest locks—enabling ships to travel between Lake Superior and the lower Great Lakes.

#### AUGUST 26: LITTLE CURRENT, MANITOULIN ISLAND (GEORGIAN BAY)


